The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The minutes of the January 13th Council meeting were read and adopted by motion of B. W. Thiessen and Ed. Saurette.

By-Law #879 Passed.

Wm. F. Recksiedler-Otto Bunkowsky: That By-Law No. 879, being a By-Law for the purpose of repealing By-Law No. 871, having been read a first time, be now considered as having been read a second and third time and passed.

By-Law #880 Passed.

B. W. Thiessen-Maurice Ribordy: That By-Law No. 880 being a By-Law for the purpose of opening as a Public Road that portion of SW 6-5-1W as shown on a plan of survey made by Alan L. Hayward, and sworn to on December 6, 1960, having been read a first time, be now considered as having been read a second and third time and passed.

Aid Re. Mrs.Oryniak increased.

Otto Bunkowsky-Wm. F. Schellenberg: That the monthly aid to Mrs. Susan Oryniak of Rosenort be increased to \$60.00 a month, commencing February 1, 1961 and continuing to May 1st.

B. W. Thiessen-Wm. F. Recksiedler: That we request the Water Control and Conservation Branch to install a bridge East of Sec. 32-4-2W and a Ford Crossing East of Sec. 33-4-2W, both on the Shannon Creek Flood-way.

Maurice Ribordy-Otto Bunkowsky: That each Councillor be appointed Enumerator in his Ward to make up the List of Electors for 1961 and enumerators be paid at 10 cents per name listed.

Reconstruct P.T.H. #23 East.

Ed. Saurette-Wm. F. Schellenberg: Whereas P.T.H. #23 East from Morris to P.T.H. #59 is an integral part of a road system for the residents of Southern and South Western Manitoba to points East,

Therefore, the Council of the Rural Municipality of Morris requests that priority be given this highway in 1961 for reconstruction from Morris To P.T.H. #59. Carried.

Ed. Saurette-Wm. F. Recksiedler: Whereas the Marsch River as commonly known on the East side of the Red River is the outlet for numerous drains in the municipalities of Franklin, Montcalm, Morris, Desalaberry and Ritchot;

Marsch River Clean-Out.

AND Whereas said river does not function properly due to fill in by silt, plugs, beaver dams, brush and debris, thus creating stagnant pools which become a menace to humans and animals alike;

THEREFORE the R. M. of Morris requests a survey be taken of the Marsch River to remedy said matters.

FURTHERMORE, that said cost estimates be submitted to the municipalities affected and that the Government through the Water Control & Conservation Branch, pay two-thirds of the cost of reconstruction, replacement of bridges where required, and the additional one-third cost be paid on a pro rata basis between the five municipalities concerned.
