The Council of The Rural Municipality of Morris held its regular meeting on the above date with all members present. The Minutes of the March 8th Council Meeting were read and adopted by motion of C. J. Neufeld and Ed. Saurette.

Gravel Contract. Otto Bunkowsky-Wm. F. Schellenberg: That we contract with John Dueck, R.R.1, Morris, to haul and crush gravel for our 1963 gravelling program at the following price:
Hauling at 7½¢ per yard per mile hauled AND
Crushing at 55¢ a yard loaded on trucks. Carried.

Grant Requested for Main Market Roads. Wm. F. Recksiedler-Wm. F. Schellenberg: That we apply to the Department of Public Works for a grant of 60% of the proposed expenditures on the following Main Market Roads:

1. Aubigny-Sperling Road	26 miles
2. Kane-Sperling Road	10 miles
3. Lowe Farm-Horndean Road	7 miles
4. Lowe Farm-Rosenfeld Road	6 miles
5. Sewell Road	9 miles
6. LaSalle Road	11 miles
7. Lowe Farm-Brunkild Road	12 miles

at an estimated cost of \$30,000.00. (Government Share.....\$10,500.00) Carried.

Request Re Special Grant for School Division Bus Routes. Otto Bunkowsky-C. J. Neufeld: That we request the Department of Public Works for a Special Grant of 60% of the cost of gravelling the following School Division Bus Routes:

- 1, East of Sec. 8, S of 17, E of 18, 19, 30 & 31-4-2W- 6 miles @250 yds or \$4,500.00 estimated cost.
2. East of Sec. 7, S of 18, W of 18 & 19-4-1W, and W 24, 30 and 31 in 4-2W. 7 miles @250 yds or \$5,250.00 estimated cost.
3. E of Sec 17, S of 20 and E 19, 30 & 31-4-1E; 5 miles @250 yds or \$3,750.00 estimated cost.
4. N of 34, S of 27 & 28, E of 20 and NW'ly 29 and S of 31 in 5-1E and E 7-6-1E; 7 miles @250 yds or \$5,250.00 estimated cost.
5. N of 34, 35 & 36-5-1W; 3 miles @250 yds or \$2,250.00 estimated cost.

Total estimated expenditure: \$21,000.00. Carried.

Request Re Special Grant for Street Gravel. Wm. F. Schellenberg-Ed. Saurette: That we request the Department of Public Works for a Special Grant for gravelling streets in the following Villages in our Municipality:

REQUEST Re Grant re St.Mary's Road. Ed. Saurette-M. Ribordy: That we request the Department of Public Works for a special Grant of 60% for re-gravelling the St. Mary's Road from River Lot 338 to 528, 13 miles, at 250 yards per mile, at an estimated cost of \$8,125.00. Carried.

Approval of Construction Program on Boundary Drain. Wm. F. Recksiedler-Wm. F. Schellenberg: Whereas the proposed 1963 Construction Program on the "Boundary Drain" D.M.D. "F" is estimated to cost \$38,790.00; And Whereas the Province will assume 1/3 of the cost or \$12,930.00 with the Municipalities of Rhineland, Morris and Montcalm jointly assuming the remaining 2/3 or \$25,860.00; Now therefore, be it resolved that the Municipality of Morris approves the construction of the above project on the basis of the above estimated expenditures. Carried.

Seed Grain By-Law passed. Wm. Recksiedler-M. Ribordy: That By-Law No. 903 being a By-Law for the purpose of furnishing Seed Grain and Fodder to farmers in 1963, having been read a first time, be now considered as having been read a second and third time and passed. Carried.

Carried.


Accounts.
