The Council of The rural Municipality of Morris held its regular monthly meeting on the above date with all members, excepting Maurice Ribordy, present. The minutes of May 12th meeting were read and adopted by motion of Ben Klassen and W.F.Recksiedler.

G.Goossen-W.Recksiedler: That we authorize the closing of the Office from June 19th to June 23rd inclusive, while the office staff is attending a Course in Municipal Administration, and that the expenses connected therewith be paid by the municipality.

H. Earl-E.Saurette: That we purchase a trophy, value of \$15.00, to be presented to the winner of the Steer Wrestling Contest in the forthcoming Manitoba Stampede.

Ben Klassen-H.Earl: That By-Law No. 956, being a By-Law for the purpose of transferring the lands of the Kronsweide 8.D. No. 1030 to the Lowe Farm Consolidated S.D. No.. 2377, be read a first and second time and submitted to the Minister for his approval.

G.Goossen-E.Saurette: That we request the Manitoba Planning Commission to include the Rural Municipality of Morris in the planning scheme now in existence with the Town of Morris. Carried

B.Klassen-E.Saurette: That the changes of ownership in apportionment of assessment as Isieta by the Assessor, dated April 26th, be approved and the Secretary authorized to place same on the 1967 Assessment Roll. (Sec. 1023 (3) of the Municipal Act.

W.F.Recksiedler-G.Goossen: That we request Manitoba Hydro that the propsed high voltage line running South from the Village of Sperling , l mile East of Provincial Road No. 336, be located so that the inside pole king will not be more than $1\frac{1}{2}$ feet onto the road allewance.

B. Klassen-G.Goossen: That we make a donation of \$25.00 to the Mental Health Association for use in entertaining mental patients during the Manitoba Stampede and Exhibition.

B.Klassen-E.Saurette: That we grant the Morris Centennial Committee \$40.00 towards centennial celebrations on July 1st, in honor of the Districts Elderly Citizens.

- Low G. Goossen-H.Earl: That we request the Water Control & Conservation Branch to brush the lower portion of the "Lewis Coulee" through Sec's: 22 and 23, Twp. 6, Rge., 1 W.P.M. to improve drainage con-
- B. Klassen-W.Recksiedler: That we request the C.N.R. to install a culvert thru its track at NE corner of Sec. 31-4-1 W, as well as lower the existing culvert at NW 31-4-1 W in order to alleviates flooding conditions prevalent at the Lowe Farm Cemetery. Carries

G.Goossen-E.Saurette: That the accounts as approved by the Finance Committee for \$20,213.33 be passed for payment.

A petition by wheaters ratepayers of the Rosenort Cons. S.D. was received praying for the transfer of the East Half of Sec. 14 and all of Sections 1, 12 and 13, Twp. 5, Rge 1 WPM to the Consolidated S.D. of Morris #2421. All persons opposing this transfer will be heard by Council on Friday, July 14th, at 2 p.m.

The Secretary was instructed to order Safety Hats for the Bridge Crew and Equipment operators.
