The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members, excepting M. Ribordy present. It was moved by B.Klassen, seconded by H. Earl that the minutes of August 11th meeting be adopted as read.

W. Recksiedler-E.Saurette: That the increase in assessments as shown in "Exhibit A" of the Assessment Branch, dated August 28th, 1967, be added to the current Tax Roll, as provided for in Sec 1051 of the Municipal Act. Carried

B.Klassen-G.Goossen: That the Court of Revision for the purpose of hearing complaints against ~~Real~~ Real Property, Personal Property and Business Assessments, changes in ownership and acreage, and deletions from the 1968 Assessment Roll, be set for FRIDAY OCTOBER 13th, 1967 at 2:00 p.m. Carried

H. Earl-E.Saurette: That By-Law No. 963, being a by-law for the purpose of setting the meeting place of electors for nominations of candidates for Councillors & Reeve for 1968 & 1969, having been read a first time, be now read a second & third time and passed. Carried

W.Recksiedler-G.Goossen: That we approve the purchase of the following attachments for our equipment:

Ben Klassen-H.Earl: That we make application for assistance under Section 3 of the Prairie Farm Assistance Act for that portion of Township 4, Range 2, WPM, which was severely hit by hail and is estimated to yield less than 8 bushels per acre. Carried

B. Klassen-W.Recksiedler: That we tender for the lowest price on permanent glycol-base Anti Freeze, in one gallon containers; quantity required: 80 gallons. Tenders to be in hands of the Secretary-Treasurer by September 18th, 1967. Carried

G.Goossen-B.Klassen: That we pay Jake Penner, Lowe Farm, \$1.75 an hour, effective Sept. 1, 1967, as operator of the John Deere 300 and Front End Loader. Carried

G. Goossen-H. Earl: That the accounts as approved by the Finance Committee for \$84,143.30 be passed for payment. Carried.

In attendance at the meeting were the following:

Mr. Williams of the Highways Department to discuss and report on various resolutions submitted by the municipality pertaining to drainage improvements.

Peter Langes, Architect for the new municipal building, presenting samples of materials to be used in the walls and floors of the new structure. - Mutual agreement was voiced as to removing of the evergreen hedge on the present location.

The Meeting adjourned after some discussion regarding the forthcoming Nomination Day on October 4th.
