

RURAL MUNICIPALITY OF MORRIS

The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members excepting Reeve Charles Anderson and Councillor Maurice Ribordy present. The minutes of October 13th council meeting were read and adopted by motion of Ben Klassen and G. Goossen.

Deputy Reeve W.F.Recksiedler chaired the meeting.

H.Earl-G.Goossen: That each member of Council and the Secretary be allowed \$30.00 towards attending the Municipal Convention and Hotel room reservations be paid by the municipality.

Ed. Saurette-H. Earl: That By-Law No. 966, being a by-law for the purpose of redeeming Part of River Lot 446 of the Parish of St. Agathe and owned by Elie St. Jacques, from Tax Sale, due to incorrect description of property sold, be read a first time, be now read a second and third time and passed.

E.Saurette-G.Goossen: That we permit the hunting of Foxes from Snow Vehicles or Aircraft within the limits of the municipality, and authorize the Secretary to submit applications by residents of the municipality, to the Wild Life Branch, for approval. A vote was taken on the question, which carried, with the dissenting vote being registered by Harold Earl.

Ben Klassen-Ed. Saurette: That we request the Manitoba Hydro to install: One 175 Watt Mercury Vapor light in the Village of Kane at the East end of Main Street.

G.P.Goossen-H.Earl: That Ward 2 and 3 donate \$100.00 towards the Rosenort Hockey Club, to be apportioned as follows:

Ward 2 - \$25.00 and Ward 3- \$75.00.

Ed. Saurette-B.Klassen: That Ward 4 donate \$200.00 towards the Aubigny Hockey Club c/o Rev. L. Caron, Secretary.

Ben Klassen-Ed. Saurette: That we pay Mrs Esther Holmes of Sperling \$90.25 a month aid, commencing Nov. 1, 1967, as provided for in Schedule "A" of By-Law No. 952.

G.P.Goossen-E.Saurette: That the accounts as approved by the Finance Committee for \$55,065.34 be passed for payment.

Two councillors of the R. M. of DeSalaberry interviewed council re installing a trap on an inter-municipal drain - request granted.

Mr. M.J.Gusta of Selkirk approached council regarding purchasing of our D 6 Cat and dozer & winch. He offered \$5,500.00, however, council felt that \$6,000. was the minimum. No final decision was made.


A request by Mr. Jacob Penner, Lowe Farm, to have his medical premium paid by the municipality was denied.
