
The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date, with all members present.
B.Klassen-M.Caron: That the minutes of August 8th Council Meeting be adopted as read.

- Moyer Drain Survey W.Recksiedler-B.Klassen: That we engage the services of a surveyor to survey Right-of-way purchases along the "Moyer Drain" from Section 7 and 8 in Twp. 4, Rge 1 EPM and Sec's: 11 and 12 in Township 4, Range 1 WPM (North Side). Carried
- P.F.R.A., H. Earl-G.Cretton: That we make application for assistance under Sec. 3 of the Prairie Farm Assistance Act for that area in our municipality marked on the attached map, which is estimated to yield less than 8 bushels on the average, per acre. Carried
- Eventide Home grant request H. Earl-G.Goossen: That we approve of the request being made by the Morris Eventide Home to the Provincial Government for an Elderly and Infirm Persons Housing Act grant. Carried
- Children's Aid canvass B.Klassen-W.Recksiedler: That we grant permission to the Children's Aid Society of Central Manitoba to conduct a canvass for funds in our municipality. Carried
- B.L. 992 Road widening NW 32-6-1E G.P.Goossen-M.A.Caron: That By-Law No. 992, being a by-law for the purpose of acquiring land for the widening of a Public Road on NW 32-6-1EPM as shown outlined on a plan of survey dated May 22, 1969, having been read a first time, be now read a second and third time and passed. Carried
- Tax Roll additions Gib Cretton-W.F.Recksiedler: That additions to the Tax Roll as listed in "Exhibit A" of the Provincial Municipal Assessor, dated July 31, be entered in the current Tax Roll and a demand for taxes mailed to the respective owners of these properties. (Sec 1051 M.A.) Carried
- Rat extermination G.Goossen-M.Caron: That we enter into a 12 months agreement with "Poullins Exterminators" of St. Boniface, to exterminate rats on our Nuisance Grounds at Lowe Farm, Sperling and Rosenort. Carried
- culvert at R.L. 438 M. Caron-H.Earl: That we request permission from the Highways Dept. to install a 42" culvert thru P.R. 246 north on River Lot 438 for a proposed drain. Carried
- Highway culverts G. Cretton-W.Recksiedler: That we request permission from the Highways Dept. to install culverts at the following locations:
1. SW 19-6-1WPM - 2. SE 24-6-2 WPM
3. NW corner of the SW 31-5-1 WPM. Carried
- Clean Ditch 24-6-2W G. Cretton-B.Klassen: That we request the Highways Dept. to clean out the road ditch East of Sec. 24-6-2 WPM along P.R. 332. Carried
- Accounts H.Earl-B.Klassen: That the accounts as approved by the Finance Committee for \$141,276.19 be passed for payment. Carried
