W.F. Recksiedler-B. Klassen: That the Council be authorized to attend the "Municipal Officials" seminar in Brandon from March 4th to 5th inclusive and expenses connected therewith be paid by the municipality.

M.A. Caron-W. Recksiedler: That we make an advance of \$1,000.00 to the Morris-Montcalm Weed Control District on the 1970 levy.

G. Cretton-M.A. Caron: That the accounts of \$12,777.73 as approved by the Finance Committee be passed for payment.

W. Jorgensen, J. Lewis and J. March solicited financial support for the Riverview Golf and Country Club. No action was taken, as council felt that it would first want to set its 1970 budget.

Mayor Dave Burke, Cliff Mitchell, Roy Dulder & Ralph Jenkins attended and informed council of a proposed Winery to be set up on the property south of Town. This would involve bringing the water to this plant and into our municipality. Joint study by councils of the 2 corporations regarding this matter, will be made.

A letter from Dr. D. Penner regarding Chicken and Hog Barns stated: "No person shall keep poultry within 100 yards of the boundary line of his property and if hogs are being kept, they shall not be kept within 200 yards of the boundary line of your property.

No person in possession of premises used for keeping of birds, poultry, or animals, shall be allowed to let the premises become offensive or to adversely affect the health or comfort of other persons by reason of filthy conditions, offensive odours and other causes."

A tentative date for studying the 1970 Budget was set for Wednesday, February 18th
