## RURAL MUNICIPALITY OF MORRIS Morris, Man.

June 12, 1970

The council of the Rural Municipality of Morris held its regular monthly meeting on the above date, with all members present. The minutes of May 8th meeting were adopted upon motion of M.Caron & H.Earl.

G. Cretton-B. Klassen: That all members of Council and Office Staff be authorized to attend the annual meeting of the Eastern Distfict of the Union of Manitoba Municipalities, to be held at Brunkild, Man. Friday June 26th, and be paid \$10.00, per member delegation expense.

W.Recksiedler-G.Cretton: That we donate \$25.00 to the local Mental Health Association for use in entertaining ex-mental patients at the 1970 Manitoba Stampede.

H.D.Earl-M.A.Caron: That we donate a Trophy for the Steer Wrestling contest to be held at the Manitoba Stampede in July.

Geo. Goossen-Ben Klassen: That we make a grant of \$300.00 to the Manitoba Branch Lines Association.

M.Caron-H.Earl: That we request the Manitoba Hydro to remove one back lane light situate behind the Church Rectory, in the village of Aubigny.

Caron-Earl: Be it resolved that the municipality of Morris hereby undertakes to save harmless and agrees all claims of injury or damage to persons or property of the Manitoba Hydro, arising out of, or in any way attributable to the construction , installation, maintenance or use of such Hydro poles used for attachment of decorations, festoon lighting, banners, flags, or any of these, as shall more specifically determined from time to time.

Ben Klassen-W.Recksiedler: That we hire Ovila Collette as checker in the gravel pit at \$1.75 an hour and 10¢ a mile travelling expense, and John D. Martens as checker of gravel on roads at \$1.85 an hour and 10¢ a mile travelling expense.

Marcel Caron-Harold Earl: That we request the Department of Public Works to install overhead lighting at the bridge over the Red River on Provincial Road #205, near the village of Aubigny.

Geo Goossen-H. Earl: That we make a request to the Municipal Planning Branch of the Dept. of Municipal Affairs to include the whole area of the Rural Municipality of Morris in its planning services scheme.

Earl-Caron: That we request the Water Control Branch to replace the 18" culvert at NW 2-5-1 WPM with a 24" culvert, to improve drainage in this area.

W.F.Recksiedler-G.Cretton: That the accounts as approved by the Finance Committee for \$22,741.05 be passed for payment.

It was agreed to purchase 48 feet of 54 inch culvert for use on the boundary drain between DeSalaberry & Morris at Sec. 25-5-2E and a 36 foot culvert, 36 inch, for a crossing a J. Verrier, Aubigny.

Councillors Goossen, Caron & Earl were to investigate the re-location of the Rosenort Nuisance Grounds, as the present site is too low and almost inaccessible.

J.J. Toews & David Thiessen again presented the School Tax problem of the previous Kane School District. Council will check with R.M. Roland.

Dave Friesen attended regarding the May 1969 petition requesting a high level bridge across the Morris River on NE 17-5-1E. Unless Government grants were made available, municipality would be unable to undertake such a project for some time.

Persons wishing to remove old car bodies from their property should contact their Councillor for instruction as to disposal of same.

Dr. D. Penner and Sam Spade of the Southern Health Unit reported on their findings regarding a proposed piggery at Elmer Penner, Rosenort. The meeting adjourned.
