Sept. 11, 1970

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. It was moved by H.Earl, seconded by M.Caron that the minutes of August 14th Council Meeting be adopted as read.

Gib Cretton-B.Klassen: That we request the Municipal Planning Branch to prepare an amendment to our present Planning Scheme, to include the remaining portion of the municipality in said scheme.

W.F.Recksiedler-Ben Klassen: That we order 75 planks 3"x12" - 24 ' Fir, from Billinkoff's Ltd. a n d the following signs from Western Safety Signs;
12 - Stop signs 24x24 - 12 Checkerboard signs 24x24
6 - Winding Road signs 24x24 and 7 foot posts for same.

G. Cretton-B.Klassen: That we make application for assistance under Sec. 3 of the Prairie Farm Assistance Act for that area in our municipality marked on the attached schedule, which is estimated to yield 10 bushels or less per acre.

G.P.Goossen-H.Earl: That we request the Manitoba Hydro to relocate the following street lights in Silver Plains:-
One 175 W light from Pole #3 to Pole #1 on the Elevator road, and
One 175 W light from Pole #3 to Pole #7 on Provincial Road #205.

Gib Cretton-Ben Klassen: That we request Manitoba Hydro to install 175 watt M.V. Street Lights in the Village of Sperling at:
"Waddell Street" - "United Church" - and "Henry Street".

Geo Goossen-M.A.Caron: That the Court of Revision for the purpose of hearing complaints against Real Property, Personal Property a n d Business Assessments for 1971, be held on Thursday, October 15, 1970 at 1:30 p.m.

Marcel Caron-G.P.Goossen: That we tender for 80 gallons of Glycol-base ANTI-FREEZE in 1 gallon containers, for immediate delivery. Tenders to be in hands of the Secretary by Sept. 18th.


George Goossen- Harold Earl: That we accept the offer of Peter Martens Rosenort, to sell for the sum of \$1.00, that portion of NE 9-6-1 EPM, shown on map attached, for the purpose of extending out Nuisance Ground.


