The Rural Municipality of Morris

October 9, 1970

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. It was moved by Harold D. Earl, seconded by Geo. Goossen that the minutes of Sept. 11th meeting be adopted as read

Sept. 18th-Ben Klassen-W.Recksiedler:- That we accept the tender of Riverside Service, RRI, Morris, offering to sell 80 gallons of Antifreeze in one gallon containers at \$2.14 per gallon.

Harold Earl-M.A.Caron: That the proposed Plan of Subdivision of part of SE 29-5-1 EPM prepared by Wildon, Neal & Hayward, land surveyors, be and same is hereby approved by the council of the R. M. of Morris, providing that the Western boundary of Lot 5 on said plan will be a projection northerly of the western boundary of Lots 1 & 3 of said proposed plan.

W.F.Recksiedler-Gib Cretton: That we request the Water Control Branch to cut and clear brush and trees in the Morris River, to improve drainage, commencing in the Village of Rosenort thence northerly.

H. Earl-G.Goossen: That we request the Water Control Branch to furnish us with an estimate of cost for construction of a year round Bridge across the Morris River at NE 17-5-1 EFM.

M.A.Caron-G.Cretton: That each Councillor delegated to go to Kettle Rapids project at Gillam be paid one-half the plane fare (\$15.00).

W.F.Recksiedler-Ben Klassen: That By-Law No. 1004 being a by-law for the purpose of closing that portion of a Public Highway contained within the limits of NW 8-4-1 EPM as shewn on a plan filed in Winnipeg LTO as #617, having been read a first time, he now read a second & third time and passed.

Harold Earl- Marcel Caron: That the expense allowance for attending the Union of Manitoba Municipalities Convention be set at \$25.00 per day, per delegate.

G.P.Goossen-M.Caron: Whereas a petition by 173 petitioners has been received by Council requesting a new and higher bridge be built across the Morris River in the Village of Rosenort, and whereas this location is flooded every spring, disrupting heavy farm and commercial traffic from East and West of said river, Now therefore, council requests that the Highways Department place this project on the 1971 priority list for construction.

G.Cretton-B.Klassen: That we make a grant of \$87.85 to the Lowe Farm Chamber of Commerce, to offset the interest it had to pay regarding the Centennial project of a skating rink.

M.Caron-W.Recksiedler: That we request the Highways Department to install a culvert thru P.R. 246 North of River Lot 352 to improve drainage in this area.

Ben Klassen-G.Cretton: That we purchase a chain saw for \$100. and an extra chain for same for \$20. from Willie Penner of Lowe Farm.

Ben Klassen-W.Recksiedler: That we purchase a Model M, single head siren or a 2 horsepower Federal siren for installation in the Village of Lowe Farm.

Gib Cretton-G.P.Goossen: That the accounts as approved by the Finance Committee for \$74,011.63 be passed for payment.
