

RURAL MUNICIPALITY OF MORRIS

December 11, 1970 - 9 a.m.

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. It was moved by H.Earl, seconded by M.Caron that the minutes of November 13th meeting be adopted as read.

W.F.Recksiedler-Ben Klassen: That P.H.Klassen, Abram H. Harder and Henry Hildebrand be authorized to attend the "Cat Care Meeting" of Powell Equipment Co. on January 27, 1971 and same be paid their usual salary of a 10 hour day, plus travelling expense.

G. Cretton-B. Klassen: That we subscribe to a half-page ad in the Morris Collegiate year book "The Beacon" at a cost of \$20.00

G.P.Goossen-H.Earl: That we give a Turkey to all municipal employees as a Christmas present.

M.A.Caron-Gib Cretton: That we pay Andre Marion an honorarium of \$100.00 for services rendered in supervising the municipal weeds mowing program in 1970.

Ben Klassen-G.P.Goossen: That we subscribe to a full page ad in the Valley Agricultural Society prize list for 1971 at a cost of \$30.00.

Geo Goossen-W.Recksiedler: That By-Law No. 1005 being a by-law for the purpose of cancelling certain Taxes which are considered uncollectable, having been read a first time, be now read a second and third time and passed.

W.F.Recksiedler-Ben Klassen: That By-Law No. 1006 being a by-law for the purpose of opening a drain across Sections 11 and 12 in Township 4, Range 1 W.P.M. having been read a first time, be now read a second and third time and passed.

M.A.Caron-GIB Cretton: That By-Law No. 1007 being a by-law for the purpose of opening a drain across Sections 7 and 8 in Township 4, Range 1 E.P.M. having been read a first time, be now read a second and third time and passed.

G. Cretton-W.Recksiedler: That the accounts as approved by the Finance Committee for \$20,777.99 be passed for payment.

The requirements of the new Municipal Act, in so far as the population of Wards is concerned, received some attention. This calls for approximately the same number of inhabitants in each Ward. Further study on this matter will be made by Council and recommendations as to boundary changes of Wards brought to the next meeting.



Harold Earl reported on the meeting held December 7th, regarding Recreation for the Town of Morris and surrounding area.


15 parcels of land were sold at Tax Sale with the municipality being the main purchaser.
