## 1971 INAUGURAL MEETING

## of The Rural Municipality of MORRIS

## Friday, January 8th

The Declaration of Qualification and Declaration of Office was taken and subscribed to by each member of Council and deposited with the Clerk. Sec. 65.

Reeve Charles W. Anderson then called the meeting to order upon which the minutes of the 1970 inaugural meeting were read and adopted by motion of Gilbert Cretton and Ben Klassen.

George Goossen-Marcel Caron: That the Deputy Reeve, Chairmen and Vice Chairmen of the various committees be elected for 1971 by secret ballot of Council.

That we appoint GILBERT CRETTON as Deputy Reeve for the year 1971.

That the Council as a whole act as a ROADS committee for 1971 and that HAROLD EARL be chairman and MARCEL CARON vice-chairman of said committee.

That the Council as a whole act as a DRAINAGE committee for 1971 and that WILLIAM F. RECKSIEDLER be chairman and BEN KLASSEN vice-chairman of said committee.

That the Council as a whole axt as the FINANCE committee for 1971 and that GILBERT CRETTON be chairman and George GOOSSEN vice-chairman of said committee.

That the Council as a whole act as the EQUIPMENT committee in charge of municipal machinery, and that BEN KLASSEN be chairman and GIB CRETTON the vice-chairman of said committee.

That the council as a whole act as the PROTECTIVE SERVICES committee in charge of Disposal Fields, Derelict Car Bodies, Fire Protection, etc., w i t h BEN KLASSEN as chairman and HAROLD EARL as vice chairman of said committee.

Marcel Caron-Harold Earl: That we appoint the firm of "Slater, Braun & Schmidt" of Morris as solicitors for the municipality for 1971.

Ben Klassen-W.F.Recksiedler: That we approve of giving First, Second and Third readings to By-Laws No's: 1008 and 1009 at this meeting. Sec. 183(2). M.A.

Harold Earl-M. Caron: That By-Law No. 1008 being a by-law for the purpose of fixing the time and place of meetings of the Council and the indemnity for same, for the year 1971, having been read a first time, be now read a second x and third time and passed.

Gib Cretton - Ben Klassen: That By-Law No. 1009 being a by-law for the purpose of fixing the remuneration of the Office Staff for the year 1971, having been read a first time, be now read a second and third time and passed.

M.Caron - W. Recksiedler: That the rental rate for the Municipal Residence occupied by the Secretary of the municipality be set at \$30.00 a month.

Geo. P. Goossen - Harold Earl: That the inaugural meeting adjourn and council re-convene to consider the regular business of the corporation.
