

THE RURAL MUNICIPALITY OF MORRIS

February 12, 1971

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. It was moved by Ben Klassen, seconded by Gib Cretton that the minutes of January 8th meeting be adopted as read.

Feb.10

Harold Earl-Ben Klassen: That we make application to the Provincial Government for a grant of \$8,000.00 to pay the labor cost of brushing the Morris River.

W.F.Recksiedler-G.P.Goossen: That we book an order from Westeel Culverts of 10 lengths of 18 inch and 10 lengths of 24 inch culverts, each in 12 foot lengths, together with couplers.

H. Earl-M.A.Caron: That the Council and staff be authorized to attend the Municipal Officials seminar in Brandon from March 3rd to 4th and the expenses connected therewith be paid by the municipality.

G.P.Goossen-Ben Klassen: That we underwrite the out-of-pocket expenses for the Fire Chiefs of our Volunteer Brigades when attending the Training Course for Fire Chiefs to be held at Gimli April 19th to 23rd.

W.F.Recksiedler-GibCretton: That we accept the tender of Shell Canada quoting 17.52 cents per gallon for our Diesel Fuel requirements for 1971, delivered to our equipment.

G.P.Goossen-Hardld Earl: That By-Law No. 1010 being a by-law to appoint, and fix and provide for the remuneration of

(a) an Enumerator; (b) a Revising Officer & (c) a Returning Officer, as required by Sec. 10(1) of the Local Authorities Election Act, having been read a first time, be read a second time. Council suspended the ~~reading~~ requirements of Sec. 183(2) and gave the third and final reading to this by-law.


