


RURAL MUNICIPALITY OF MORRIS


JUNE 11, 1971

| Minutes | Harold D. Earl-Geo Goossen: That the minutes of May 14th council meeting be adopted as read. |
| Eastern District Meeting St. Pierre | Marcel Caron-W.F.Recksiedler: That the council be authorized to attend the annual meeting of the Eastern District of the Union of Manitoba Municipalities on June 23rd, to be held at St. Pierre, and expenses incurred therewith be paid as set out in By-law No. 1008. |
| Tax Levy B.L.1013 passed | Gib. Cretton-Ben Klassen: Whereas, according to Sec. 564(4), of the Municipal Act, deficiencies in Tax Levy By-Law no. 1013 and errors in our budget have been corrected and the Director of Budgets has approved said by-law, Now therefore, By-Law No. 1013 be read a second and third time and passed. |
| Steer Wrestling trophy | Geo Goossen-M.A.Caron: That we donate a trophy to the Manitoba Stampede to be presented to the winner of the Steer Wrestling event at the stampede in 1971. |
| Open-Door-Club donation | W.F.Recksiedler-Ben Klassen: That we donate \$25.00 to the local Mental Health Association to assist them in bringing members of the "Open Door Club" to a day at the Manitoba Stampede. |
| Gravel Checker | H.D.Earl-M.A.Caron: That we hire John D. Martens as gravel checker on roads at \$1.95 an hour and 12 cents a mile travelling expense. |
| Road mowing co-ordinator | Geo. Goossen-Gib Cretton: That we appoint Andre Marion, to co-ordinate our road weed mowing program for 1971 and pay his mileage and expenses connected therewith. |
| Morris Planning Scheme 71, passed. | H. D. Earl-M.A.Caron: Whereas an "Order" has been received whereby the Minister of Urban Development and Municipal Affairs waives any requirements of public notice re the Morris Planning Scheme 1971, Now therefore adopting By-Law No. 1017 of this scheme be now given second and third reading and passed. |
| Estimates re bridge 17-5-1 E. | W.F.Recksiedler-Ben Klassen: That we ask Water Control Branch to approve or disapprove of the multi-plate structures proposed by Armco Drainage to replace the bridge at Sec. 17-5-1 EPM; Also supply an estimate of the length required of a grade level timber bridge, at this location. |
| Road blade mix for Rosenort | G.P.Goossen-Marcel Caron: That we request a grant-in-aid from the Highways department for road blade mix to be placed on the street in the village of Rosenort from P.R. 205 to "Kreeker Street". |
| Accounts | G. Cretton-W.Recksiedler: That the accounts as approved by the Finance Committee for \$28,968.35 be passed for payment. |
| Ward Boundaries | Considerable discussion arose over the Minister's decision to delay action regarding Ward Boundaries changes. Whereas our proposed Ward boundary changes have been advertised and the necessary action procedures required by "Act" well advanced, further developments are awaited before giving second reading to our By-Law. |
