

THE RURAL MUNICIPALITY OF MORRIS

July 9, 1971

The council of the rural municipality of Morris held its regular monthly meeting on the above date with all members present. Moved by Ben Klassen, seconded by G.Cretton that the minutes of June 11th regular meeting and June 29th special meeting be adopted as read.

Marcel Caron-H.D.Earl: That the Secretary-Treasurer be instructed to add to the 1971 Tax Roll those items of assessment contained in "Schedule A" of the Assessor, dated June 17, 1971, excepting there-out Roll 36200.

G.P.Goossen-G.Cretton: That By-Law No. 1018 providing for the payment of weed chemicals for the control of weeds on Part N $\frac{1}{2}$ and Part SW of section 36-6-1 WPM, and adding said cost to the taxes against this land, be read a first, second and third time and passed. Sec 183(2) of the Municipal Act was suspended in this case.

H.D.Earl-M.A.Caron: That we purchase the following bridge material from Billinkoff's Ltd. :

35 pcs 3 x 12 x 20' fir planks
35 pcs 3 x 12 x 22' fir planks and
10 pcs 4 x 6 - 18'

Ben Klassen-W.F.Recksiedler: That we agree to pay the costs of drugs required by Jacob F. Braun of Lowe Farm, when purchased at the Morris Drug Store.

W.F.Recksiedler-Ben Klassen: That we agree to share the cost of Diabetic drugs required by Cornelius Heinrichs of Morris, on a 50-50 basis with the Manitoba Dept. of Health.

G.P.Goossen-Gib Cretton: That we approve inprinciple the proposed plan of subdivision of Part SW 8-6-1EPM, Rosenort, as surveyed by H.Neumann on May 20th, 1971 and bearing survey plan #71-1327; providing that "Kroeker Street" running North and South has a minimum width of 66 feet and the street running parallel with the North Dyke be made a thru street; and furthermore, that the proposed "Kroeker Street" be constructed at the expense of the municipality and one culvert supplied to each lot owner, upon request.

W.F.Recksiedler-Ben Klassen: That Alice Loving be declared Acting Secretary-Treasurer during the absence of the Clerk while he is on holidays, and shall, while she fills this office, have all the powers and shall perform all the duties of the Secretary-Treasurer. (Sec. 155(1 & 2)).


It was agreed to engage the services of Wilson, Neal & Hayward to survey the right-of-way of that portion of the "Lewis Dran" running thru Sec's. 22 and 23, township 6, Range 1 WPM and survey the right-of-way of the River Lot Drain, thru R.L's 493 to 511.


It was reported that the road gravelling program had started; discussion followed regarding gravelling of new roads.
