

THE RURAL MUNICIPALITY OF MORRIS

DECEMBER 10, 1971

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. It was moved by W.F.Recksiedler, seconded by Ben Klassen that the minutes of November 12th meeting be adopted as read.

Marcel Caron-George Goossen: That By-Law No. 1023 being a by-law for the purpose of amending the Morris Planning Scheme of 1968 and that the Morris Planning Scheme 1971B designated Schedule "A" and attached to said by-law, be now read a first time and the necessary notices mailed to every owner of property in the area included in the scheme.

Gib Cretton-Ben Klassen: That By-Law No. 1022<sup>(A)</sup> being a by-law for the purpose of cancelling certain taxes which are considered uncollectable, having been read a first time, be now read a second and third time and passed. Sec. 183(2) of the Municipal Act was suspended in this case.

A. K. Fast-Gib Cretton: That no permits be issued in 1971-72 season for Fox hunting in the municipality.

G. P. Goossen-M.A.Caron: That we request the Highways Department for a grant-in-aid towards the black-topping of "Kroeker Street" in the Village of Rosenort in 1972, at an estimated cost of \$12 to \$15,000.

W. F. Recksiedler-Gib Cretton: That we pay Andre Marion an honorarium of \$100. for services rendered in supervising the municipal weeds mowing program in 1971.

Marcel Caron-A.K.Fast: That we authorize the purchase of a small sprayer for weed control in the municipality at approximately \$200.00

W. F. Recksiedler-Ben Klassen: That we approve the purchase of four 100 foot rolls of snow fencing and fifty 6 foot posts for same from Sutherland Supply Ltd., Winnipeg, Man.

W. F. Recksiedler-Ben Klassen: Whereas the Rural Municipality of Morris has received a request for approval in principle of the formation of a community development corporation, part of which will be in this municipality;

And Whereas the Rural Municipality of Morris agrees in principle with any organization whose aims and objects are stated to be the furtherance of progress in Southern Manitoba, and especially in the Red River Valley;

Therefore be it resolved that the Rural Municipality approve in principle the formation of the St. Jean-Baptiste Community Development Corporation Ltd. and its operation in part of the R.M. of Morris.

Jake Wiebe and Jack Moore, representing the Morris Branch of the Royal Canadian Legion approached council for assistance in the construction of an addition to the Morris Legion Hall at an estimated cost of materials of \$12,000. It was stressed that this hall was extensively used by a large portion of the community surrounding the Town and the only one available for rental.


