Ben Klassen-Gib Cretton: That the tender of GULF OIL CANADA Ltd. quoting 18.7 cents per gallon for our 1972 Diesel Füel requirements, delivered to our equipment, be accept. D

G.P.Gooseen-G.M.Cretton: That we approve in principle the proposed plan of subdivision of part SW 8-6-LEPM, Rosenort, as surveyed by H. Neumann on May 25th, 1971 and bearing survey plan #71-1327; providing that "Willow Drive" running north and south have a minimum width of 66 feet and the street running parallel with the North Dyke be made a thru street; and furthermore, that the proposed "Willow Drive" be constructed at the expense of the municipality and one culvert supplied each lot owner upon request.

W. F. Recksiedler-G.P.Goossen: That we concuré with the levies set out regarding the construction of a 40 bed "Care Home" in Morris, as set out in a schedule dated Feb. 7, 1972/

Ben Klassen-M.A.Caron: That we authorize the rental of an electric Postage Metering machine, Model 5714, for the term of one year.

G.Goossen-W.Recksiedler: That we appoint Harold D. Earl as our member to the Board of the Valley Agricultural Society for 1972.

Ben Klassen-Gib Cretton: That we subscribe to a one-page Ad in the 1972 Prize list book of the Valley Agricultural Society.

M. A. Caron-A.K.Fast: That we agree to share the cost of Diabetic drugs for "Adrien Pelland" of RR 3, Morris, Man., on a 50/50 basis with the Manitoba Department of Health & Social Development.

G.P.Goossen-A.K.Fast: That we order 300 feet of  $2\frac{1}{2}$  inch Fire Hose (double jacket) for the Rosenort Fire Brigade.

 $M_{\bullet}A_{\bullet}$ Caron-Ben Klassen: That we accept the proposal of the Manitoba Telephone System to provide toll-free calling service between the Morris and Ste-Agathe telephone exchanges at an increased rate of 66 cents a month.

M.Caron-Ben Klassen: That the accounts as approved by the Finance Committee and examined by Council, in the amount od \$13,864.76 $^{\land}$  be passed for payment.

Two welfare cases appeared before council requesting assistance. There appeared to be some question as to the authenticity of the claims made and further invesitgation by council was to be made.
