THE RURAL MUNICIPALITY OF MORRIS

March 10, 1972

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date, with all members present. Moved by A. K. Fast, seconded by M.A.Caron, that the minutes of March 6th Special Meeting and February 11thncouncil meeting be adopted as read.

M. A. Caron-G.P.Goossen: That By-LawNo. 1023 for the purpose of amending the Morris Planning Scheme of 1968 and the Morris Planning Scheme 1971B designated Schedule "A" and attached to said by-law, having received first reading, be now given second reading and submitted to the Minister for approval.

G.P.Goossen-A.K.Fast: That we agree to share the cost of Diabetic drugs for "Randy Siemens" of RR1, Morris, Man., (c/O Elsie Siemens), on a 50/50 basis with the Manitoba Department of Health and Social Development.

Gib. Cretton-W.F.Recksiedler: That we contact with Johnny Bueck, Rosenort, to truck, load and crush our Road Gravel requirements for 1972 at the following rates:

Hauling at 8 cents a yard per mile and Crushing and loading on trucks at \$1.00 a yard.

Ben Klassen-Gib Cretton: Whereas Lot 7, Block 4, Plan 522 was improperly sold at tax msale in December 1970, bearing certificate No. 10-70, having previously been sold at Tax Sale in 1969,TSC #1; Now therefore the Council of the Rural Municipality of Morris hereby redeems said property from Tax Sale. (Sec. 839(1) Mun. Act.

Geo Goossen-M.A.Caron: Whereas Lot 5, Plan 5115 except S'ly 2051 was improperly sold at Tax Sale on Dec. 11, 1970, bearing certificate No. 3-70 and purchased by the R. M. of Morris, due to incorrect advertising of said Lot Number;

Now therefore the Council of the R. M. of Morris hereby redeems said property from Tax Sale. (Sec. 839(1) Municipal Act.

W.F.Recksiedler-Ben Kalassen: That the accounts as examined by Council and approved by the Finance Committee in the amount of \$60,244.27 be passed for payment.

Gilbert Cretton reported on the Community Planning Association conference held in Winnipeg on March 1, 2nd and 3rd. He will also make his report to the committee on Regional Analysis.

It had been stressed that more authority be given and more initiative taken by local authorities as to projects required in its respective areas.

One resolution passed was asking the government to declare its intention as to the restructuring of Municipalities, in order to guide local authorities in its future planning.

The formation of regions did not appear too popular.

Harold Earl reported on the Brandon seminar for Municipal Officials. The formation of Village Committees received considerable discussion. Relationship of municipalities with the farm organizations was a major subject, with a good question and answer period.

The Education Tax Base subject resulted in a rambling a n d lengthy discussion.

Questions regarding the operations of "Auto Pac" were numerous.

Drainage works anticipated by the Water Control Branch for 1972, in our municipality were reported by Dave Sexton and two other representatives from the branch. These would include work on the 4N Dykes, The Shannon, the Kronsgart and other minor improvements.

The Drainage program of municipal drains was considered by council, with further discussion to be held at the $$\underline{\hbox{BUDGET MEETING}}$$ to be held at 1:30 p_em_e on THURSDAY, MARCH 16th.
