

RURAL MUNICIPALITY OF MORRIS

The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with the following members present: Deputy Reeve Gilbert Cretton, W.F.Recksiedler, Anton Fast, Marcel Caron and Bernhard Klassen. George Goossen was still hospitalized after suffering a heart attack. Reeve Harold Earl had a doctors appointment and could only attend the afternoon portion of the meeting. He is to undergo surgery on Tuesday.

W.F.Recksiedler-Ben Klassen: That the minutes of the June 9th council meeting be adopted as read.

Ben Klassen-A.K.Fast: That by-law No. 1028, being a by-law for the purpose of borrowing monies from the Bank of Montreal in the amount of \$75,000.00 to meet current expenditures of the corporation, be read a first and second time. The requirements of Sec. 183(2) of the Municipal Act were suspended and third and final reading given this By-Law.

M.A.Caron-A.K.Fast: That ~~the~~ by-law No. 1029 being a by-law for the purpose of opening and constructing a drain through River Lots 434 and 436 having been read a first time, be now read a second and third time and passed. Sec. 183(2) of the Municipal Act was suspended in this case.

W.F.Recksiedler-Ben Klassen: That we request the Water Control and Conservation Branch to survey the "Slater" and "Taylor" drains in preparation for reconstruction work on same.

M.A.Caron-W.F.Recksiedler: That we add to taxes on NE 36-6-1W the cost of weed chemical paid for in the amount of \$104.50 and supplied to Wilfred Marsch of Brunkild; Refer to By-law 1018.

A. K. Fast-M.A.Caron: That we authorize the Highways Department to renew municipal highway signs situate at all entries to Provincial Highways and Provincial Roads within our municipality.

M.A.Caron-A.K.Fast: That we order the following lumber from Billinkoff's, Winnipeg:

10 pcs. 24' x 3x12
50 pcs 20' - 3x12
14 pcs 16' - 4x6


delivered to our municipal yard at Morris.


Ben Klassen-W.F.Recksiedler: That we purchase about 49½ feet of Right-of-Way along the South side of SW 15, south of sections 16 and 17 in Twp. 6, Range 1 W.P.M. at \$100.00 per acre.

That a maximum of 6 culverts per mile be installed, unless otherwise authorized by Council and that Gilbert Cretton be appointed agent to purchase said right-of-way.

The accounts as examined by council and approved by the Finance Committee were passed for payment in the amount of \$75,100.60.
