

THE RURAL MUNICIPALITY OF MORRIS

OCTOBER 13, 1972

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. Moved by M.A.Caron, seconded by A.K.Fast that the minutes of September 8th meeting be adopted as read.

G.P.Goossen-M.A.Caron: That By-law No. 1036 being a by-law for the purpose of acquiring property on the NE 9-6-1E for the purpose of establishing a nuisance grounds, be read a first, second and third time and passed. Sec. 183(2) of the Mun. Act was suspended.

G. Cretton-Ben Klassen: That By-law No. 1037 being a by-law for the purpose of assigning its interests in Tax Sale Certificate #13/70 to the Bank of Montreal, having been read a first time, be now read a second and third time and passed.

W. F. Recksiedler-M.A.Caron: That By-Law No. 1038 being a by-law for the purpose of assigning its interests in Tax Sale Certificate #14/70 to the Bank of Montreal having been read a first time, be now read a second and third time and passed.

M.A.Caron-G.P.Goossen: That we agree to share the cost of Diabetic drugs for Claude Robert of Aubigny, on a 50-50 basis with the Manitoba Department of Health and Social Development.

W.F.Recksiedler-Ben Klassen: That we approve the revised requirements of the Red River Valley Lodge Inc. construction budget, which increases the costs from \$422,240. as originally estimated, to \$456,000. The revised levy for the municipality of Morris will be \$17,501.

G.P.Goossen-A.K.Fast: That the expense allowance for attending the Union of Manitoba Municipalities convention be set at \$35.00 per day per delegate.

M. A. Caron-Gilbert Cretton: That the applications of the following ratepayers, requesting to have dwelling units recorded in the Tax Roll for purpose of School Tax Reduction, be approved:
