NOVEMBER 10, 1972

The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. Prior to the meeting, Walter Anderson, chairman of the Morris Community Committee of the Regional Analysis Program, gave a report of the committee's findings to council .

Moved by Ben Klassen, seconded by Geo Goossen that the minutes of October 13<sup>th</sup> meeting be adopted as read.

G.P.Goossen-Gilbert Cretton: Resolved that plan of subdivision of part of SW 8-6-1 EPM prepared by Hans Neumann, Manitoba Land Surveyor, be and the same is hereby approved for registration.

Ben Klassen-Marcel Caron: That By-law No. 1041 being a by-law for the purpose of entering into an agreement with the Pembina Valley Development Corporation for a period of 3 years be read a first, second and third time and passed. Sec 183(2) of the Mun.Act be suspended.

The annual Court of Revision was held at 1:30 p/m. Six written appeals were presented to the court, 2 of which were granted and the other four denied. After general discussion the court adjourned.

Johnny Dueck approached council with regards to correcting a discrepancy in records pertaining to the 1972 gravelling program. The matter will receive further attention and be resolved.


