The Council of the Rural Municipality of Morris held its regular monthly metring on the above date with all members present. It was moved by W,Recksiedler, seconded by B.A.Wibe that the minutes of the Ooctober 11th meeting be adopted as read.

W.Recksiedler-M.A.Caron: That we appoint Harold D. Earl as our member to the board of the Pembina Valley Development Corporation.

M. A. Caron-G.M.Cretton: That the following be applinted as a Committee to investigate the proposal of an "Unincorplarated Village of Rosenort".

Alvin Rempel - Ben A. Wieb - Anton K. Fast.

A copy of a by-law concerning the unincorporated vullage of Rosenfeld had been received from the R.M. of Rhineland for our information. The Secretary was instructed to try to obtain by-law and budgets from the unincorpoeated villages of Niverville, Grunthal, Kleefeld and Dominion City, for further guidance.

G.M.Cretton-Alvin Rempel: That we authorize G. Cretton to purchase 1 Nozzle at \$228. and 1 Air Pack at \$502. for our Fire Brigades.

A.K.Fas t- M.A.Caron: That we approve the purchase of the following: 10 only signs "15 M.P.H." (reflectorized) and 8 foot posts. 100 - 3 x 12 x 20* Planks. 800 lbs of 6 inch nails.

7 rolls of 100° snow fencing with 8 foot posts.

Alvin Rempel-M.A.Caron: Resolved that Plan of Subdivision of Part SW 8-6-1 EPM establishing "Birch Street" in the Village of Rosenort, prepared by H.Neumann land surveyor, dated on July 16/74, be approved for registration.

Ben Wiebe-W.Recksiedler: That we authorize the closing of the office on Nov. 26-27-28 while the office staff is attending the Annual Convention of the Union of Manitoba Municipalities.

Alvin Rempel-Ben Wiebe" That Turkey s be ordered as Christmas presents for Equipment operators, Bridge Crew, Mower men, Building Custodian, the Council and Staff.

A nton K. Fast and Marcel Caron were authorized to price an d purchase same.

The Emergency Measures Organization informed of a "Disaster Readiness Education" Course to be held Dec. 2nd to 6th at Arnprior, Ontario. An application is to be submitted indicating that Gilbert Cretton would be willing to stand as a candidate for this course.

The secretary was instructed to write the Highways Department for a job well done on the "Access Road" at Sperling.

Harold Earl reported on the Official Opening of the Red River Lodge at Morris, which had been very well attended by the public. Gilbert Cretton represented the municipality on the same day, Nov.3, at the Open House of the Care Home at Altona, He had been well received. Alvin Rempel had attended the Planning meeting at Brandon on No. 1st which had proved quite interesting. Enforcing planning seemed to pose a problem and it was hoped that the 8 regional Development Groups would assume this responsibilty.

W.Recksiedler-Ben Wiebe: That the accounts as approved by the Finance Committee for \$67,597.86 be passed for payment.
