We see no serious sewage problems with septic fields at the present time, but a sewage system may be installed before Phase II of the

Subdivision is required:
And Whereas Lot 3 is not suitable for a building lot it should

be allocated for public reserve; And Whereas rezoning of land will be required, necessary steps will be taken to rezone lands to Residential, Parks, and Commercial use in this Subdivision;

And Whereas Phase I does not include the access road, we would ask the developer to build a street East and North to P.R. 205, which is part of Phase II;

And Whereas Lots 1 - 4 are to be used for Commercial use, and
