Moved by G. M. Cretton, Seconded by Dan Thiessen: #198/78. Resolved that we sell the Rosenort Flying Club one acre of land, described as the N 16.5 F. of the SW of 5-6-1E, providing that the owners of land neighboring the air strip are in agreement;

And Further that the legal fees of the transfer of land be paid by the Flying Club.

Tenders to be in the hands of the Secretary-Treasurer by noon on December 11, 1978.

Dog By Law Moved by Dan Thiessen, Seconded by A. K. Fast: #200/78. Whereas By Law #1109, being a By Law for the purpose of providing for the regulation, licensing and control of Dogs within the limits of the Rural Municipality of Morris, was introduced and read a first time the 10th day of October, 1978; Now Therefore Be It Resolved that By Law #1109, be now read a second and third time, signed by the Reeve and Secretary-Treasurer, sealed with the Corporate Seal and finally passed.

Dog Tags to be purchased. Moved by Wm. F. Recksiedler, Seconded by George St. Hilaire: #201/78. Resolved that we purchase 250 Dog Tags, with the name of the Municipality and number pre stamped, as well as the year, 1979. Carried.

Whereas By Law #1110, being for the purpose of ratification of an agreement between Municipal Corporations, and a Contractor charged with the enforcement of a Dog Control By Law, was introduced and read a first time, the 10th day of October, 1978; Now Therefore Be It Resolved that By Law #1110, be now read a second and third time, signed by the Reeve and Secretary-Treasurer, sealed with the Corporate Seal and finally passed. Carried.

Procedure By Law No. 11111, read a second time.

Whereas By Law #1111, being a Procedure By Law for the purpose of establishing rules and regulations according to the proceedings of the Council of the Municipality of Morris, was introduced and read a first time the 8th day of November, 1978; Now Therefore Be It Resolved that By Law #1111 be now read a second time.
