The Council of The Rural Municipality of Morris held a meeting, to complete the Agenda of the January 10th meeting, on Monday, January 21, 1980 at 1:40 P.M., in the Council Chambers at the Town of Morris with Reeve Alvin Rempel presiding. Present were Councillors: - Wm. F. Recksiedler, Anton K. Fast, Norman Wiens, George St. Hilaire, Dan Thiessen, and Gilbert Cretton; and Secretary-Treasurer, Alice Loving.

Correspondence Tabled at December 13, 1979 Meeting:

1. Canadian Environmental Protection Heritage Inc.-Appeal for support re Garrison Diversion. Secretary-Treasurer to write to inquire who the members are, and if this is a dual committee with the one organized by the U.S.A., and Manitoba.
2. The Morris Hospital District No. 25. - Levy for \$12,181.29. Reeve Alvin Rempel explained that the reserve had been used to pay for an overexpenditure, and the above amount will have to be levied for in 1980.

Delegation: Kelly Moss of Powell Equipment showed pictures of a Scraper, to Council.

A letter from Thompson, Dorfman, Sweatman, regarding a Public Hearing on January 29, 1980 in Brandon, for increased rates of Plains-Western Gas (Manitoba) Ltd., was read.


Discussions:-

3. Enumerator for 1980. - Secretary-Treasurer to contact Mr. Stanley Fraser, of Letellier.
4. Employee Relations Committee. - The Equipment and Bridge Employees accepted the salary schedule and working conditions for 1980, that the Council had proposed on January 10, 1980.
5. Interest paid to the Morris Macdonald School Division No. 19.- Secretary-Treasurer to write informing them that the Public Schools Act does not authorize them to charge interest, and to deduct said amount from the balance of the 1979 Levy due on January 31/80,

JANUARY 23, 1980: -

A sub committee of the Manitoba Assessment Review Committee held informal meetings with representatives from area municipal councils in the Municipal Council Room, throughout the day.

The schedule of the meetings were:
10 A.M. - Rural Municipality of Montcalm;
11 A.M. - Rural Municipality of Morris;
1;30 P.M.-Rural Municipality of Rhineland;
2:30 P.M.-Town of Plum Coulee.

Members of the sub-committee meeting with the municipal representatives were Committee Chairman Walter Weir, a former Premier of Manitoba, and Committee member, Allan Beachall, Reeve of the Rural Municipality of Rosser, and also a District Officer of the Manitoba Union of Rural Municipalities. They were accompanied by Committee Secretary, R. N. Clarkson.

Note: In 1968, on January 25th, Mr. Walter Weir, then Premier of Manitoba, cut the ribbon to officially open the new Municipal Building.

A few points discussed at the above meeting were exemptions regarding Farm Buildings, Non-elected people to form the Court, for the Court of Revision, as in Winnipeg, and Brandon. The Rural Municipalities usually have their Councillors form the Court. Winnipeg also has a different percentage for the various Businesses. The Homeowner's Grant has now changed to a redistribution of income.
