

THE RURAL MUNICIPALITY OF MORRIS

The Council of The Rural Municipality of Morris met at 9:30 A.M. on Tuesday, April 1, 1980, in the Council Chambers at the Town of Morris to have their pictures taken for the Centennial History Book, "Furrows in the Valley".

After various pictures were taken, in the Council Room, as well as in front of the Municipal Building, by Douglas J. Penner, of the Scratching River Post, Reeve Alvin Rempel called Council to order to discuss the Centennial History Book, and read the letters that Gilbert Cretton had left with the Secretary-Treasurer, at the March 27, 1980 meeting. Present were Councillors:- Wm. F. Recksiedler, Anton K. Fast, Norman Wiens, George St. Hilaire, Dan Thiessen, and Gilbert Cretton; and Secretary-Treasurer, Alice Loving.

Discussed was the number of Centennial History Books to order. George St. Hilaire gave a report regarding books published about the Grunthal area, and Ste. Pierre Jolys. Both books were not as costly as "Furrows in the Valley", and were not selling as quickly as expected.

When the material for the History Book is sent to Inter-Collegiate Press, 1/3 of the cost of the number of books ordered is expected to be paid.




