The Council of The Rural Municipality of Morris held a Special Meeting at 9:30 A.M., on Monday, June 2, 1980, in the Council Chambers at the Town of Morris with Reeve Alvin Rempel presiding. Present were Councillors: - Wm. F. Recksiedler, Anton K. Fast, Norman Wiens, George St. Hilaire, Dan Thiessen, and Gilbert Cretton, and Secretary-Treasurer, Alice Loving.

The meeting had been called by the Reeve, and the Secretary-Treasurer had notified all Council Members of same, as well as the following

1. Budget;
 2. Grasshoppers;
 3. Dykes on Roads;
 4. Gravel Program, and Checker.

Upon opening the meeting, the Reeve stated that Dyking on Roads would not be discussed today, as members from the Flood Board would be attending the June 12th regular Council Meeting.

Moved by G. M. Cretton, Seconded by Dan Thiessen:
#121/80. Resolved that we supply the Grasshopper Chemical to be used on Road Allowances, and Drainage Ditches;
And Further those ratepayers who have already sprayed will be refunded the amount of the Chemical, when they produce the bills.

Moved by A. K. Fast, Seconded by George St. Hilaire:
#122/80. Resolved that we order 124 Gallons of Dimethoate (Grasshopper Spray) from the Department of Agriculture.

George St. Hilaire reported on the gravel program. It was suggested that if Lavallee Trucking Ltd. was unable to supply the 9,000 yards of gravel, that he put it in writing that he could only supply 2,000 yards, then Council could purchase gravel from Gagne Gravel Company. The applications for Gravel Checker from, Gary Kroeker, Morris, and Yves Guillou, Aubigny, were read.

#123/80. Resolved that we hire Yves Guillou, for Gravel Checker, at the wage of \$4.50 an hour, and 22¢ per mile.

It was decided that the Flood Graveling be done first, and that the Gravel Program start tomorrow, June 3, 1980.

Moved by George St. Hilaire, Seconded by Dan Thiessen,
#124/80. Resolved that we average 90 yards of gravel, per mile;
And Further that $\frac{1}{2}$ mile of new gravel be placed on Section 6-5-2W - East Side, and 150 yards on East Side of Section 8-6-1E, as these roads did not receive gravel, as planned, in 1979;
And Further that new gravel be placed East of Section 12-4-2W, for $\frac{1}{2}$ mile, if needed.

Moved by Dan Thiessen, Seconded by G. M. Cretton:
#125/80. Whereas the streets, in Sperling, Riverside, and Lowe Farm are to be gravelled, and calcium chloride applied;
Now Therefore Be It Resolved that water be applied on the streets first, if necessary.

Budget.




Dug-outs

And Further that P.F.R.A. obtain necessary clearances to release further funding for the dugout project.
