The Council of the Rural Municipality of Morris held its regular meeting at 10:00 A.M. on Thursday, March 11th, 1982 in the Council Chambers of the R. M. of Morris.

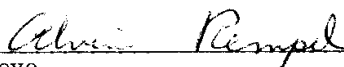
Reeve Alvin Rempel presided.

Present were Councillors: George St. Hilaire, Dan Thiessen, Lenore Eidse, Glenn Curdt, W. F. Recksiedler, Roy Kornelsen.

- Minutes Moved by Glenn Curdt, Seconded by Dan Thiessen:  
#62/82. Resolved that the minutes of the February 11, 1982 regular meeting and the February 24th, 1982 special meeting be now adopted as recorded and the reading of same shall be waived.  
Carried.
- Ste. Moved by George St. Hilaire, Seconded by Roy Kornelsen:  
Agathe #63/82. Resolved that the Council of the R. M. of Morris is prepared  
Arena to participate with the R. M. of Richot and the R. M. of Macdonald to consider the establishment of a joint community centre district to repay the debt created by the Ste. Agathe rink area.  
The area of the R. M. of Morris being considered to be included is:  
River Lot 504 to 528  
River Lots 497 to 527  
Section 33-6-2E and the N½ of Sec. 32-6-2E.  
Carried.
- Ste. Moved by Glenn Curdt, Seconded by W. F. Recksiedler:  
Agathe #64/82. Resolved that Alvin Rempel, George St. Hilaire and Grant  
Arena Macaulay be authorized to attend the joint municipal meeting  
Meeting regarding the Ste. Agathe Arena and that the R. M. of Richot are to establish the date for the meeting.

- Delegation Mr. Moffat of the Water Resources Branch met with Council at 11:30 a.m. to discuss the Roberts-McTavish drain and its subsidiary drains. Mr. Moffat informed Council of the proposal of the work on the main drain that the province would be doing and that which the municipality would be required to do. Cost estimates for these projects would have the Provincial cost being \$700,000.00 and the Municipal cost estimate being \$340,000.00 based on the aspect that all the work is done at a certain rate. If the Municipality were to do its own work, the cost would be considerably less. Mr. Moffat stated that the Municipal drains to be done totalled about 35 miles. Mr. Moffat left a draft copy of the agreement and plans for the drains to be done and after a general discussion on the matter the delegation ended. Mr. Moffat asked that the agreement should be finalized as soon as possible.
- Council then recessed for lunch at 12:15 P.M. to reconvene at approximately 1:15 P.M.
- Delegation Mrs. Godkin and Mrs. Brown representing the Morris Swim Pool met with Council to request financial assistance. They presented Council with a listing of those taking lessons at the pool and the area municipality in which they lived. They then discussed the budget for the pool and they informed Council that their major financial problem was meeting the payments for the bank loan which they currently have. They were informed by Council that the matter would be further discussed and reviewed when setting our 1982 budget.

And Whereas they have not supplied the required surveys as of this date;  
Therefore Be It Resolved that the Council of the R. M. of Morris request these plans by July 31st, 1982.

#71/82. Resolved that By-law No. 1203/82, be now given second and third readings in Council as a whole with the requirements of Section 183(2) of the Municipal Act being now suspended.

#72/82. Resolved that we purchase one drum of oil from Hitrac.  
Carried.

#73/82. Resolved that we now approve the list of Accounts for March 11, 1982 in the amount of \$56,479.95 plus the following accounts:
