

THE RURAL MUNICIPALITY OF MORRIS

The Council of the Rural Municipality of Morris held it's regular meeting at 10:00 A.M. on Thursday, May 13, 1982 in the Council Chambers of the R.M. of Morris.  
Deputy Reeve Dan Thiessen presided  
Present were Councillors Glenn Curdt, Roy Kornelsen, Lenore Eidse, and W.F. Recksiedler.

- Minutes Moved by Glenn Curdt, Seconded by Roy Kornelsen:  
#131/82, Resolved that the minutes of the April 8th, 1982 regular meeting and the April 22, 1982 special meetings be now adopted as recorded and the reading of same shall be waived with an amendment to the April 22, 1982 Morris C.C.D. reports to read the tractor tenders was for rental purchase.  
Carried.
- Air Conditioner Moved by W.F. Recksiedler, Seconded by Lenore Eidse  
#132/82, Resolved that we authorize the repair to the air conditioner unit at a cost of 1,030.00 and purchase carpet in the School Division Office at a cost of approxiamately \$800.00

Craig Ostien of Wsetman Culvert and Metal met with Council to discuss possible Culvert purchases for 1982. He also mentioned that at present they were giving a 90 day extended term on payments for purchases.

- New Rates Equipment Moved by W.F. Recksiedler, Seconded by Roy Kornelsen  
#133/82 Whereas the R.M. of Morris periodically sets new rates for the rental of the municipal equipment; And Whereas the Council of the R.M. of Morris does now wish to adjust such rates; Therefore Be It Resolved that effective May 1, 1982 the R.M. of Morris does now implement the 1981 Provincial Government rental rates as the new equipment rental rates for the Rural Municipality of Morris, plus the rate for Mower or Tree planter with operator to be set at \$20.00 per hour.

- Purchasing Land, Alvin Rempel Moved by Glenn Curdt, Seconded by Lenore Eidse  
#134/82, Whereas the Rural Municipality of Morris is installing a sewer and water system into Rosenort, Manitoba;  
And Whereas the proposed site for the sewage lagoon is on the NE $\frac{1}{4}$  of Section 9-6-1East;  
And Whereas this property is owned by Mr. Alvin Rempel who is a member of the Council of the Rural Municipality of Morris;  
And Whereas Mr. Alvin Rempel has agreed to sell part of the above mentioned property for the purpose of constructing a sewage lagoon;  
Therefore Be It Resolved that the Rural Municipality of Morris does now approve the entering into a contract to purchase from Mr. Alvin Rempel the North 708 feet of the South 1,013 feet of the West 392 feet of the NE $\frac{1}{4}$  of Section 9, in Township 6, and Range 1East of the Principal Meridian at a cost of 527.84 per acre.

Mr. Lou Small and Mr. Fred Mayor of Manitoba Telephone System met with Council to discuss the work for this area. They stated that M.T.S. was planning only maintenance work for this area. However, they mentioned that for raod work being done by the R.M. of Morris, advance notification should be made to their office. This allows them time to check and mark the M.T.S. lines.
- The Deputy - Reeve then opened the floor for the rezoning hearing for the NW $\frac{1}{4}$  of 32-4-2W being for By-Law 1207/82.  
No representations were made to Council in this regard.

The hearing for the rezoning of part of Lot 6 of River Lot 450 to "GC" was then opened. There were no persons present or representations made regarding this rezoning.

Carried.


Street Moved by Glenn Curdt, Seconded by Lenore Eidse

New Street.


Carried.
