The Council of the Rural Municipality of Morris held its regular meeting at 9:00 A.M. on Thursday, July 14th, 1983 in the Council Chambers of the R. M. of Morris.

Reeve Alvin Rempel presided.

Present were Councillors: Lenore Eidse, W. F. Recksiedler, Glenn Curdt, George St. Hilaire, Roy Kornelsen, Dan Thiessen.

- Minutes Moved by George St. Hilaire, Seconded by W. F. Recksiedler:
#343/83. Resolved that the minutes of the June 9th, 1983 regular meeting and the June 16th, 1983 special meeting be now adopted as presented.
Carried.
- Museum Moved by Glenn Curdt, Seconded by Lenore Eidse:
Selling #344/83. Resolved that the Morris Museum be authorized to sell the
Hist. Bks R. M. of Morris History Book with their receiving a commission of
\$3.00 per book sold.
Carried.
- Weed Moved by Roy Kornelsen, Seconded by George St. Hilaire:
Tour #345/83. Resolved that our members on the Morris Montcalm Weed
Control Board be authorized to attend the Regional Weed Tour at
Carman on July 26th, 1983.
Carried.
- Sale of Moved by Dan Thiessen, Seconded by Lenore Eidse:
pumps #346/83. Resolved that we sell our excess sewage pumps from the
Lowe Farm sewer system to Mr. Jake Brown at a cost of \$100.00 per pump.
Carried.
- Financial Moved by Glenn Curdt, Seconded by Roy Kornelsen:
Statement #347/83. Resolved that the Financial Statement for the month of
June, 1983 be now adopted as presented by the Secretary-Treasurer.
Carried.
- Fire Moved by Roy Kornelsen, Seconded by Dan Thiessen:
Reserve #348/83. Whereas in 1980 the Rural Municipality of Morris did build
Withdrawal a fire hall and purchase a fire truck for the Rosenort Fire Department;
And Whereas resolution no. 57/80 gave indication that the municipality
intended to withdraw the amount of \$58,000.00 to be used towards
the purchase and construction of the above mentioned items;
And Whereas the amount of \$54,047.00 was requested and approved to be
withdrawn from the Fire Equipment Reserve;
And Whereas there are still outstanding accounts of this project which
require to be paid;
Therefore Be It Resolved that the Rural Municipality of Morris does
now request the Minister of Municipal Affairs to approve the withdrawal
of \$3,953.00 from the Fire Equipment Reserve in order to clear
outstanding accounts relating to the above mentioned projects.
Carried.
- Delegation Representatives from Manitoba Hydro and the Provincial Planning
Branch met with Council and discussed the aspects of their hearings
and demonstrations which Hydro has held with regards to the Mandan
Line proposal. They also answered some questions from Council and
heard comments of Council regarding this proposed line. Following
a general discussion on the project they indicated that once a line
route has been selected, they would again return to meet with Councils
in the early fall to discuss the chosen route.
- Hiring Moved by Lenore Eidse, Seconded by George St. Hilaire:
Extra #349/83. Resolved that Mr. August Berthelette be hired to work for
Bridge the Bridge Crew of the municipality as a temporary worker and that
Crew the employees committee will set the time limit he is to work for.
Carried.
- Delegation Mr. Bruce Gregory and Mr. Art Toews met with Council to discuss the
Red River Corridor development. The area along the Red River have
many basic similarities and concerns. The other municipalities of the
area has passed resolutions of support for the area towards the
formation of a development corporation. They asked Council for a similar
show of support for the formation of a Red River Development Corporation.
Council indicated that they would decide upon the matter in the very
near future.
