

Morris, Manitoba.
October 17th, 1941.

The Council met as a Court of Revision on the above date at 1 P.M. with all the members present.

Three appeals were filed and dealt with. The Imperial Oil Company appealed against Assessment at Lowe Farm and Sperling, the Company being represented by Mr. M. Neill. After a thorough discussion the Council decided to instruct the Assessor to make the following reductions:

- Lowe Farm Buildings from \$3000.00 to \$2500.00.
- Sperling Buildings from \$1700.00 to \$1550.00.

An appeal was heard from Paul Braun but it was a case of being assessed for lots that he did not own, he was advised that in future the lots would be assessed to the owner.

An appeal was filed by P.P. Funk who owns the building that the Co-Operative has Stock in, he was advised that the Stock was assessable to the Lowe Farm Co-Operative.

Messrs. Andersen appealed against the assessment of the Manse at Union Point but there was nothing that the Council could do in connection with same.

The Assessor produced a list of changes of Ownership also a list of new Assessments and same was examined by the Council and passed.

There being no further appeals the following resolution was passed:

Moved by Councillor Snarr,
Seconded by Councillor Davidson,

That there being no further appeals the Assessment Roll, the Court of Revision be closed and that the Assessor be authorized to make the changes as recommended by the Council and that the Roll as revised, be the Assessment Roll for the year 1942, and that this Council meet at once in regular session. Carried.

The Council met in regular session at 3 P.M. The minutes of the last meeting held September 19th were read and adopted as read.

Major Oakes of the Salvation Army appeared before the Council asking for the usual grant.

Moved by Councillor McDonald,
Seconded by Councillor Stevenson,

That this Council make a grant of \$150.00 to the Salvation Army. Carried.

Representatives of the Powell Equipment Company and the Canada Ingot Iron Company spoke to the Council in connection with snow removal equipment. Prices of same were left with the Council.

A list of lands liable to be sold for arrears of taxes was laid on the table and the following resolution was passed:

Moved by Councillor Spalding,
Seconded by Councillor Griffiths,

That Whereas the Secretary Treasurer has submitted a list of all lands within the Municipality so liable to be sold for arrears of taxes pursuant to the Statutes, and Whereas the Council desires that a Sale of lands for taxes be held.

Now Therefore, the Council directs the Reeve in his discretion to take all proper proceedings as required by Statute to collect said taxes by sale at the earliest possible moment. And further, if for any reason, sufficient buyers are not present at the sale to purchase the different parcels, the Reeve is hereby authorized and instructed to purchase the said parcels in the name of the Rural Municipality of Morris. Carried.

By-law No. 650 was read a first time,
Moved by Councillor McDonald,
Seconded by Councillor Spalding,

That By-law No. 650 being a by-law for the purpose of providing for the nomination and election of a Reeve and three

Councillors for the years 1942-1945 having being read the first time be now considered as having being read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal same. Carried.

Councillor McDonald explained that it was necessary to change nurse in connection with Frank Palud.

Moved by Councillor McDonald,

Seconded by Councillor Stevenson,

That Alex Larivierre replace Rosalie Guillon in caring for Frank Palud at a price of \$15.00 per month. Carried.

An application for Old Age Pension was received from Robert Smith Levitt.

Moved by Councillor Griffiths,

Seconded by Councillor Davidson,

That this Council recommend Robert Smith Levitt of the Village of Sperling for Old Age Pension, payment to start when eligible.

A letter was read from Mrs. M. Mazolleck re Tax Sale in connection with her property, the Clerk was instructed to write a solicitor for an assignment of Tax Sale Certificate.

Communications received from the Child Welfare in connection with Mrs. Guenther, the Unemployment Insurance Commission re Employment Union of Manitoba Municipalities, Re the annual meeting, from Messrs. Bernier & Bernier re Mrs. Roy, and from C. L. Lount re sale of culverts, were read.

After the different communications were discussed, it was decided, to order some culverts from the C. L. Lount Company at a later date, also to write Messrs. Bernier & Bernier in connection with Mrs. Roy's accident.

Bills and accounts were presented to the Finance Committee, the Committee reported that the Clerk be authorized to pay the accounts as per list.

Moved by Councillor Stevenson,

Seconded by Councillor Davidson,

That the report of the Finance Committee be accepted and that the Reeve and Clerk be authorized to issue cheques for the several accounts. Carried.

The meeting then adjourned to meet on November 21st.
