Morris, Manitoba. August 18th, 1944.

The Council met as a Court of Revision to revise the Elector's Roll on the above date. All the members were present with the exception of Councillor Davidson.

The minutes of the former meeting were read and declared adopted as read.

The Councillors and the Assessor made the necessary changes in the list. This being completed the following motion was passed:

Moved by Councillor Griffiths, Seconded by Councillor Anderson,

That the Court of Revision in regard to the Elector's Roll be closed and that the Elector's Roll as revised be the Elector's Roll for the year 1944, and that the Clerk be instructed to have 100 copies printed. Carried.

The Clerk laid a list on the table, of all lands liable to be sold for arrears of taxes. After same was inspected by the Council the following resolution was passed:

Moved by Councillor Interest,
Seconded by Councillor Griffiths,
That Whereas the Secretary-Treasurer has submitted a list of all lands within the Municipality so liable to be sold for arrears of taxes pursuant to the Statutes, and Whereas the Council desires that a sale of lands for taxes be held.

Now Therefor, the Council directs the Reeve in his discretion to take all proper proceedings as required by Statutes, to collect said taxes by sale, at the earliest possible moment. And further, if for any reason sufficient buyers are not present at the sale to purchase the different parcels, the Reeve is hereby authorized and instructed to purchase the said parcels in the name of the Rural Municipality of Morris. Carried.

> By-Law No. 681 was read a first time. Moved by Councillor Griffiths,

Moved by Councillor Thiessen,

Seconded by Councillor Thiessen,

That By-Law No. 681 being a by-law for the purpose of authorizing the purchase of right-of-way from Albert Recksiedler (Section 12-4-1W.) at a price of \$30.00 per acre, having been read the first time be now considered as having been read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal same. Carried.

A communication was read from the Department of Munitions and Supply re fuel. Same was ordered filed.

A letter was read from the Department of Health re Mrs. Sawatzky. The Reeve stated he would have a certificate from Dr. Holowin forwarded in comnection with her health.

A letter was received from Dr. A. E. McGavin in connection with the immunization of children in Ward Six. He stated the fee he received from Dufferin Municipality was \$2.00 per child. The Clerk was instructed to advise him the fee paid by Morris Municipality was \$1.50 per child.

A letter was received from the Department of Health regarding John A. Guenther asking if suitable work could be obtained for him. The Clerk was instructed to advise the Department that work of the nature recommended for him was not obtainable in Lowe Farm.

A reply was read to the enquiry sent to the Fair Wage Board in connection with rate of wages paid. The Board stated their schedule did not apply to Municipalities unless work was let by contract.

A letter was read from A. Chisholm in connection with a ditch at Section 5-5-2E. The Reeve explained that the work was done under the supervision of both Councils and seemed satisfactory.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Treasurer is authorized to pay the accounts as per list.

Moved by Councillor Griffiths, Moved by Councillor Thiessen,

That the report of the Finance

Committee be accepted and the Reeve and Clerk be authorized to issue cheques for the several amounts. Carried.

The meeting then adjourned at 3.30 P.M. to meet in regular meeting on September 15th at 1.00 P.M.
