Eight appeals were dealt with as per assessment appeal Register and the following resolution was passed:

That the Court of Revision be closed, and the Assessment Roll as revised be the Assessment Roll for the year 1946, and that the Assessor make the necessary changes as authorized by the Council, and that this Council now meet in regular session. Carried.

The minutes of the former meeting held September 21st were read and declared adopted as read.

> B y-Law No. 694 was read the first time. Moved by Councillor Davidson,

Moved by Councillor Davidson,
Seconded by Councillor McDonald,
That by-law No. 694 being a by-law for the purpose of providing for the nomination and election of a Reeve and three Councillors for the years 1946 and 1947, having been read the first time be now considered as having been read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal same. Carried.

A letter was read from the Director of the International Peace Garden Inc. asking that the Municipality make a contribution towards the maintenance of same.

Moved by Councillor Stevenson,

Moved by Councillor Anderson,

That a grant of \$10.00 be paid towards the maintenance of the Canadian portion of our Peace Garden. Carried.

Mr. Hamilton, representative of the Canada Ingot Iron Company, interviewed the Council in connection with the sale of a Snow-Plow. Moved by Councillor Stevenson,

Seconded by Councillor Anderson,

That the Municipality of Morris order a Snow-Plow with wing, lights and heater, from the Canada Ingot Iron Company. Carried.

An offer of \$35.00 was received from Henry Bobrowski for the remnants of the Old Silver Plains Ferry but this was not accepted.

Moved by Councillor Griffiths,

Moved by Councillor Thiessen,

Seconded by Councillor Thiessen,

That the old ferry at Silver Plains

November 13th. 194 be advertised for sale in the Free Press, offers to be in by November 13th, 1945. Carried.

Communications were read from the Canadian National Railways re culvert, Manitoba Sanatorium re travelling T.B.Clinic, Union of Manitoba Municipalities re annual convention to be held November 28, 29 & 30th, Manitoba Good Roads Association re convention on 9th November, and the Manitoba Power Commission re free festoon lighting during 9th Victory Loan.

A petition was presented to the Council by the residents of Sperling asking for police protection on Hollowe'en night and that automobile speeding be curbed. The Clerk was instructed to forward same to the Attorney-General.

Two communications were read from the Department of Public Works stating (1) that the Minister had authorized a grant of \$3,853.50 to the

Municipality, Government share on a 50-50 basis, covering work on the Morris-Ste. Elizabeth Road; and (2) stating that the estimated cost of work required to be done in the Municipality re Morris-Ninette Road being  $\sqrt{24}$ ,215.00 as submitted by the engineers, this on the 2/3 - 1/3 basis.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Treasurer is hereby authorized to pay the accounts as per list.

Moved by Councillor Griffiths,

Moved by Councillor Thiessen,

That the report of the Finance

That the report of the Finance Committee be accepted and the Reeve and Clerk be authorized to issue cheques for the several amounts. Carried.

Applications for the position of Secretary-Treasurer for the Municipality was then considered and discussed. Fourteen applications were received and it was decided that the Reeve and one Councillor interview the Municipal Commissioner in connection with same.

The meeting then adjourned until Friday November 16th at one o'clock.
