Schellenberg.

Aid Re R.Davidson, Sperling. Otto Bunkowsky-Wm.Recksiedler: That the aid of \$25.00 a month for Robert Davidson, Sperling, as approved on March 13th, be made payable to Canadian National Institute for the Blind.

Purchase of No.12 Cat

Otto Bunkowsky-Wm. Recksiedler: That we purchase one No.12 Caterpillar Motor Grader Serial No. 8T-17089 with snow plow and wing from Powell Equipment Co. Ltd. for the price of \$25,960.00 with a trade-in allowance of \$1,960.00 for our elevator grader. Rental payment of \$7,000.00 made in December 1955 to be considered as payment on account. Carried.

By-Law #825 read a first time. Wm. Recksiedler-H. B. Giesbrecht: That By-Law #825 being a By-Law for the purpose of ratifying the supplementary scheme for living quarters for the staff at the Altona Hospital No. 24, and authorizing the necessary taxation under the wcheme, be now read a first time and forwarded to the Municipal & Public Utility Board for approval.

Wm. Schellenberg-Otto Bunkowsky: WHEREAS the "La Salle Rodd" extending through the Municipalities of Morris and Macdonald, from No. 75 P.T.H. at Morris, in a north-easterly direction to No. 3 P;T.H. at East 4-10-2 East, is a municipal responsibility for maintenance and upkeep.
