The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The minutes of the December 11th Council meeting were read and adopted by motion of Ed. Saurette and Wm. Recksiedler.

Aid to Retarded Children.

B. W. Thiessen-Wm. Recksiedler: That we agree to pay \$10.00 a month to "Schools for Retarded Children" who give instruction to children of electors of our Municipality who classify as Retarded Children.

Carried.

Survey request- Drainage Mtce. Board.

Ed. Saurette-Otto Bunkowsky: That we request the Drainage Maintenance Board to survey the following locations for the purpose of constructing drainage ditches:

1. Through River Lots 432 to 448 inclusive.
2. North of River Lot 464 and North of Sections 11 and 12 in Township 6 in Range 2 E.P.M.
3. South of Section 8 and Northerly of Section 8 on half mile line in Township 5, Range 2 E.P.M.

Arbitrator Appointed- Tache S.D. #937

Wm. Recksiedler-Wm. F. Schellenberg: That we appoint Zeph Odette of Otterburne as arbitrator regarding the petition of Michel Parent and others requesting the dissolution of the Tache S.D. #937 and transferring its lands to the Consolidated S.D. of St. Jean Baptiste #2362 and St. Joseph S.D. #945.

Carried.

Arbitrator Appointed- Provencher & Ste. Agathe S.D.'s.

Ed. Saurette-Otto Bunkowsky: That we appoint Zeph Odette of Otterburne as arbitrator regarding the petition of Henri St. Onge and others requesting the transfer of River Lots 461 to 483 inclusive, from the Provencher S.D. #997 to the Consolidated S.D. of Ste. Agathe #2385. (also Sec 18-6-2E & Part Sec 17-6-2E)

Carried.

By-Law #870 Passed.

Ed. Saurette-Otto Bunkowsky: That By-Law No. 870 being a By-Law for the purpose of supplying street lighting to the Village of Aubigny for the years 1960 to 1964, by the Manitoba Power Commission, having been read a first time, be now considered as having been read a second and third time and passed.

Carried.

By-Law #871 Passed.

B. W. Thiessen-Otto Bunkowsky: That By-Law No. 871 being a By-Law for the purpose of opening a road (First Avenue through part of SW 6-5-1W) in the Village of Lowe Farm, having been read a first time, be now considered as having been read a second and third time and passed.

Carried.

Accounts.

Maurice Ribordy-B. W. Thiessen: That the accounts as approved by the Finance Committee for \$20,357.92 being 1958 accounts, be passed for payment.
