APRIL 8, 1960.

The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The minutes of the March 11th Council meeting were read and adopted by motion of Wm. Recksiedler and M. Ribordy.

- Weight Restriction. B. W. Thiessen-Wm. Schellenberg: That we set a weight restriction on loads on all roads in the Municipality of Morris: "Not to exceed 250 lbs. per inch width of tire per axle."
Carried.
- Site Re. W. I. Marker. Wm. Schellenberg-Wm. Recksiedler: That we permit the Historic Sites Advisory Board to erect a marker on the North East corner of the grounds of the County Court Building, being in honour of the 50th Anniversary of the Women's Institute of Morris.
Carried.
- School Arbitrator Appointed. Ed. Saurette-Otto Bunkowsky: That we appoint Zeph Odette of Otterburne as arbitrator regarding the petition of Louis D. Nolette and others, requesting the transfer of: River Lots 609, 611, 613, 615, 617, 619, 621, 623, 625 and 627, from the Cartier School District #100 to the Ste. Agathe Consolidated School District #2385 in the Red River School Division No.17.
Carried.
- 1959 Electors' Roll to be adopted for 1960. M. Ribordy-B. W. Thiessen: That the 1959 Electors' Roll be adopted for the year 1960 (Sec. 50 (3 & 4) of the Municipal Act) and the Court of Revision in respect to same be held on June 10th at 2 o'clock in the Court House Building at Morris, Man., and the Secretary -Treasurer be and is hereby authorized to amend the last revised List of Electors.

- By-Law #873 Re budget passed. Wm. Recksiedler-Wm. Schellenberg: That By-Law No. 873, being a By-Law for the purpose of making estimates of all sums required for the lawful purposes of the corporation for the year 1960 and setting out the various rates, as shown in "Schedule A", having been read a first time, be now considered as having been read a second and third time and passed.
Carried.
- Aid Re Effie Mihiaczuk. Ed. Saurette-B. W. Thiessen: That we pay \$25.00 a month aid to Effie Mihiaczuk of Aubigny commencing April 1, 1960.
Carried.
- Street Light requested-Lowe Farm Curling Rink. B. W. Thiessen-M. Ribordy: That we request the Manitoba Power Commission to install one 100 Watt Street Light at the Lowe Farm Curling Rink, connected to the Lowe Farm Village Street Lighting system.
Carried.
- Accounts. Otto Bunkowsky-Wm. Recksiedler: That the accounts as approved by the Finance Committee for \$42,120.71 be passed for payment.
Carried.
