

RURAL MUNICIPALITY OF MORRIS

By Law #1106 - Pt. SW 29-6-2W, on the West Side of Main Street, Sperling;
By Law #1107 - Pt. SW 29-6-2W, on the East Side of Main Street, Sperling;
By Law #1108 - Pt. NE 6-6-1E.

2 P.M. - No representation regarding By Law #1106: -

By Law #1106, re-classifying Pt. SW 29-6-2W, read a second and third time.
Moved by G. M. Cretton, Seconded by George St. Hilaire: #178/78. Whereas By Law #1106, being a By Law of the Rural Municipality of Morris, for the purpose of re-classifying Pt. of the SW 29-6-2W, from "A40" to "R.A."
