

THE RURAL MUNICIPALITY OF MORRIS

The Council of The Rural Municipality of Morris held its regular meeting beginning at 10:15 A.M., on Thursday, June 14, 1979, in the Council Chambers at the Town of Morris with Reeve Alvin Rempel presiding. Present were: Councillors - Wm. F. Recksiedler, A. K. Fast, Norman Wiens, George St. Hilaire, and Dan Thiessen; and Secretary-Treasurer Alice Loving.

Minutes. Moved by George St. Hilaire, Seconded by A. K. Fast:
#109/79. Resolved that the minutes of the meeting held May 10, 1979, and those of the Special Meeting held on June 4, 1979, be adopted as read.


