

RURAL MUNICIPALITY OF MORRIS

PUBLIC MEETING

A Public Meeting was held in the Council Chambers of the Municipal Building in the Town of Morris, at 9:30 A.M., on Monday, June 18, 1979, with Deputy Reeve, Gilbert Cretton presiding. Present were: = Councillors - Wm. F. Recksiedler, A. K. Fast, Norman Wiens, George St. Hilaire, and Dan Thiessen; and Secretary-Treasurer - Alice Loving.

Mrs. Barbara Shewchuk, Reporter, Scratching River Post, in attendance.

The Following proposed rezonings had been duly advertised, and the By Laws presented to Council:

By Law #1121 - 60.96 metres in depth to the immediate south of the most Easterly 100 feet of Lot 8 and Lots 9, 10, 11 and 12, Plan No.9962, to be reclassified from "A40" Rural to "GC" General Commercial District.

By Law #1120 - Portion of Lot 6, lying east of a straight line drawn Southerly at right angles to the Southern limit of Lot 7, from the south-west angle of Lot 7, Plan 11846, to be reclassified from "R-A" Suburban District to "C-2" Central Commercial District.

There was no representation for either By Law.

By Law #1121, re-classifying from "A40" Rural to "GC" General Commercial District.

Moved by A. K. Fast, Seconded by George St. Hilaire: #117/79. Whereas By Law #1121, being a By Law, for the purpose of amending District Map 3 of the Morris Planning Scheme 1968, as it affects the proposed Rosenort Development Corporation was read a first time May 10, 1979; And as a Public Hearing was held at 9:30 A.M., Monday, June 18th, and there was no representation; Now Therefore Be It Resolved that By Law #1121 be now read a second and third time, signed by the Reeve, and Secretary-Treasurer, sealed with the Corporate Seal, and finally passed. Carried.

By Law 1120, re-classifying from "R-A" Suburban to "C-2" General Commercial District.

Moved by George St. Hilarie, Seconded by Wm. F. Recksiedler: #118/79. Whereas By Law #1120, being a By Law for the purpose of rezoning certain lands classified from "R-A" Suburban District to "C-2" Central Commercial District, was read a first time the 12th day of April; And as a Public Hearing was held at 9:30 A.M., Monday, June 18th, with no representation; Now Therefore Be It Resolved that By Law #1120 be now read a second and third time, signed by the Reeve and Secretary-Treasurer, sealed with the Corporate Seal, and finally passed. Carried.

The Public Meeting adjourned.

Council reconvened in General Meeting, with the following being discussed:

1. Planning.-The Secretary-Treasurer asked if the procedure of obtaining a building Permit, in the Flood-Prone Lands, would be altered. Council made no decision to change the procedure.
2. Float for the Stampede Parade.-Council to get together at the Municipal Shed on June 25th, at 7:30 P.M.
3. Manitoba Good Roads Association.-Annual Competition.-Enter the Grounds of John Kostal, R.L. 474, Plan 4122, in Best Farm Home Grounds. No roads, or Village to be entered.
4. Manitoba Telephone System.-Council marked proposed construction work on Map.
5. Gravelling.- to start soon, but no new miles of road to be gravelled until June 26th.
6. Trailer for the Bridge Truck---Committee to look at an advertised one. If it is suitable, Councillor Thiessen stated he would move the resolution to purchase it, at the next meeting.
7. Procedure of ordering Bridge Materials and Culverts.-Table till next meeting.

Legal Advise re Sperlina Arena.

Moved by G. M. Cretton, Seconded by Norman Wiens: #119/79. Resolved that we contact Braun, Schmidt and Gregory to advise Council on the procedures of all aspects of the proposed Sperlina Arena.




Moved by G. M. Cretton, Seconded by George St. Hilaire:
