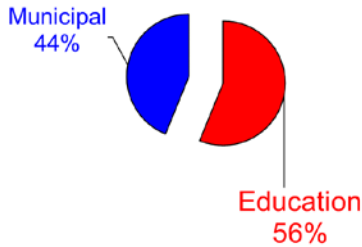

## ASSESSMENT

Every couple of years the Provincial Assessment Department conducts a Province wide reassessment. The next re-assessment will take place in 2022 and be effective for 2023. The current assessment is based on the market value as of April 1, 2018.

## MUNICIPAL PORTION

The Rural Municipality of Morris has recently approved its municipal budget. In 2020 the Municipality budgeted to collect municipal taxes in the amount of \$4,147,928.18 and in 2021 this amount is budgeted to be \$4,290,520.11.

In 2021 the Rural Municipality of Morris has budgeted expenditures totaling \$6,428,434.26, excluding education payments. The graph on the next page shows where the budget has been allocated.

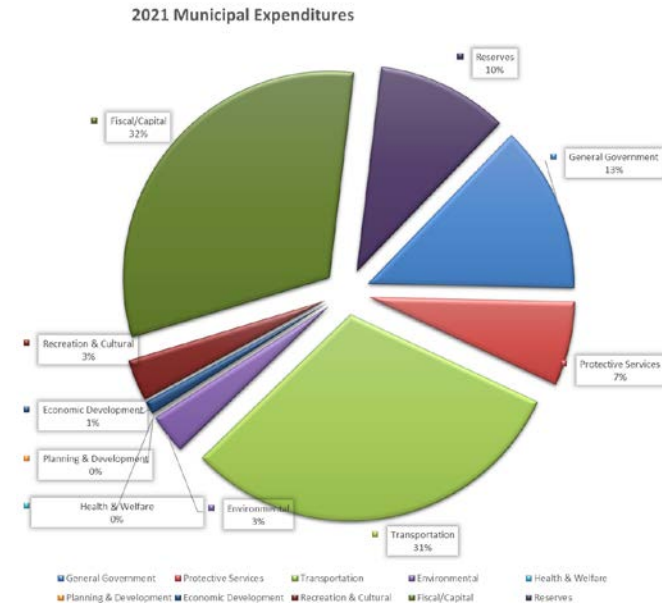
